**Terms and conditions:**

1. **Age limit:** Not more than 35 years for PVERA, SRF and YP-I as on the last date of application submission. Age relaxation of **five years** for SC/ST/woman candidates and **three years** for OBC can be considered. In case of deserving qualified candidates already working in the establishment or in similar temporary service in central government in the subject area, the age limit shall not apply, but shall not be above 65 years of continuous service.
2. The candidate intending to attend for interview, if any of his near or distant relative is an employee of the PPV&FR Authority, have to declare his/her name, designation, nature of duties, relationship in advance in writing during submission of the application form
3. Candidate will have to forward the application in prescribed format only, scanned self-attested photocopies of all the required certificates/marksheet from secondary onwards, tabulated information of publications and experience certificates, if any. All original or provisional degree/mark sheets from Secondary examination onwards, Date of Birth proof, UG/PG certificates/Grade cards/mark sheets, credentials, working experience, if any, will have to be produced by the successful candidate at the time of joining for verification, failing which, the offer of appointment will be deemed cancelled.
4. Last date for submission of application is **21 days from the date of advertisement published in the Employment News**. 6. The posts are purely on temporary basis and will be filled on contractual basis initially for period of one year which may be extended periodically subject to performance or till the termination of the project.
